- A state license must be obtained through the Georgia State Department of Revenue (DOR) before any your local license must be provided to the state for processing. Contac the Department of Revenue at Alcoholic beverages can be sold or served. If you are applying for a alcohol beverage license, a copy of 1-877-423-6711 OR you may - Email: atdiv@dor.ga.gov.
- □ Upon completion of the non-criminal history/background check, Chatham County Occupational Tax Division will schedule an appointment with applying applicant to submit Alcoholic Beverage Fees.

The applicant shall be required to comply with all rules and regulations for the granting of new licenses as if no previous license had been held. This will include a reassessment of all investigative, administrative, and any other State or Federal fees. Any renewal applications received after January 31 shall require a reapplication for an alcoholic beverage license and the application fee will be assessed at Failure to renew the Alcoholic Beverage License by January 31 will result in suspension of the Alcoholic Beverage License with notification to the State of
