

**A RESOLUTION BY THE BOARD OF COMMISSIONERS OF CHATHAM COUNTY
SETTING QUALIFYING FEES FOR THE 2024 ELECTION AND AUTHORIZING
PUBLICATION OF SAME**

WHEREAS, O.C.G.A. § 21-2-131 requires the governing authority of each county, not later than February 1 of any year in which a general primary, nonpartisan election, or general election is to be held, to fix and publish a qualifying fee for each county office to be filled in the upcoming primary or election; and

WHEREAS, a general primary, nonpartisan election, and general election are scheduled to be held in 2024;

NOW, THEREFORE, BE IT RESOLVED that the Board of Commissioners of Chatham County, as the governing authority of Chatham County, does hereby set qualifying fees for candidates for the county offices to be elected in 2024 as set forth in Exhibit "A" attached hereto.

BE IT FURTHER RESOLVED, that the clerk of the Chatham County Board of Commissioners is authorized and directed to publish the list of qualifying fees in accordance with the requirements of O.C.G.A. § 21-2-131 no later than February 1, 2024.

THIS RESOLUTION is adopted and made effective this 10th day of January, 2024.
