Chatham County Tax Commissioner's Office to Open New Satellite Office in Bloomingdale, Ga. on May 1

SAVANNAH, Ga. (April 24, 2024) – The <u>Chatham County Tax Commissioner's Office</u> recently announced that a new satellite office is set to open on Wednesday, May 1 in Bloomingdale, Ga. for the convenience of local taxpayers who live in west Chatham County.

The new satellite office will be located inside the Bloomingdale City Hall, 8 U.S. Hwy. 80, and will be open by appointment only on Wednesdays and Fridays from 8:30 a.m. to 4:30 p.m. Chatham County residents can <u>schedule an appointment online</u> at <u>tax.chathamcountyga.gov</u> or by calling **(912) 652-7100**.

"Our new satellite office in Bloomingdale will make conducting property tax payments and mobile vehicle transactions more convenient for residents in west Chatham County," said Chatham County Tax Commissioner Sonya L. Jackson. "Opening this new office is part our ongoing commitment to bringing our services out into the community to better serve Chatham County taxpayers." The Bloomingdale satellite office will join three existing Chatham County Tax Commissioner's Offices:

Southside Office: 1145 Eisenhower Dr.

Westside Office:

295 Police Memorial Drive (off Chatham Parkway)

The Chatham County Tax Commissioner's Office also operates satellite locations on Wilmington Island at 125 Wilmington Island Rd. and in Port Wentworth at 7224 GA-21. Both offices are open by appointment only. For additional information, please visit tax.chathamcountyga.gov.

ABOUT THE CHATHAM COUNTY TAX COMMISSIONER'S OFFICE:

Under State law, the Chatham County Tax Commissioner is responsible for the administration of the billing and collection of current and delinquent ad valorem taxes due the State of Georgia, Board of Education, Transit Authority, Chatham County, Chatham County municipalities, and Special Service District on real and personal property as well as mobile home taxes, public utility taxes, timber taxes, heavy duty taxes, street lighting fees, and solid waste fees. In addition, the Tax Commissioner is responsible for the billing and collection of ad valorem taxes and Title Ad Valorem Tax due the State of Georgia, Board of Education, Transit Authority, and Chatham County municipalities at the time of title application and tag renewal. Under the leadership of Chatham County Tax Commissioner Sonya L. Jackson, the Tax Commissioner's Office operates three convenient offices to serve citizens, including a Downtown Savannah location at 222 W. Oglethorpe Ave. #107, a Southside Savannah location at 1145 Eisenhower Dr., and a West Chatham location at 295 Police Memorial Dr. For more information, please contact **(912) 652-7100** or **tax@chathamcounty.org**.
